## Lots going on in Washington Team. We start off with Chris Wright's rapid fire Constitution Minute.

- Chris returned to the discussion of whether or not the Mueller appointment is constitutional. Two weeks ago he said it was constitutional but tonight he talked about Mark Levin who argued the contrary on his radio show and Levintv. Levin provides a compelling argument as to why the Mueller appointment is unconstitutional based on the Constitution, scholarly legal opinions and court opinions.
- 2. Presidential Pardons: In sum, a president cannot issue a pardon during impeachment proceedings and cannot issue pardons involving state crimes and/or civil liability cases and cannot grant pardons to "groups" of Americans at a time. Finally, the question was asked whether President Trump can pardon himself from the Mueller investigation? No definitive answer but may opine that if he did it would most likely result in his impeachment. (*This is quite ironic since Mueller's sole purpose right now is to ensure that if the majority goes to the House after the midterm elections that the president is impeached.*)

**Bill Pascoe-Our Man in Washington** gave his rapid fire Washington Report. A couple of items worth highlighting. On the FBI front, House conservatives introduced a resolution last Tuesday calling for a second special counsel to investigate possible misconduct by the DOJ and FBI during the 2016 presidential race.

- 1. The discharge petition. The House needs 218 needed votes to pass the Discharge Petition and vote on 4 immigration bills: Three Republican lawmakers are leading efforts to get the majority of Republican House members to sign the "discharge petition." If it passes, the House will then vote on four immigration proposals using the "Queen of the Hill" rule. This means that the proposal receiving he most votes beyond a majority would pass the House and go on to the senate. The four proposals are 1) HR 4760 Securing America's Future Act aka the Goodlatte bill. This bill is supported by President Trump. 2) HR 4796 USA Act of 2018. This will give "dreamers" a chance to stay in the US. 3) HR 3440 The Dream Act and 3) A leadership alternative put together by the Speaker of the House that is not yet available. Right now 22 republicans have signed on to pass the discharge petition and they need another 6 Republicans to sign on. It is imperative that you call your representative and tell them "don't you dare sign this discharge petition and don't you dare vote for anything that includes Amnesty.
- 2. President Trump has placed steep steel and aluminum tariffs coming from Canada, Mexico and the E.U. Many countries announced retaliatory tariffs.
