Welcome to the Tea Party Patriots Weekly National Leadership Call Report. Glad you stopped by.

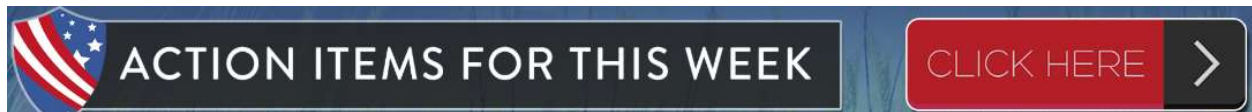
